BORROWING CLUB EQUIPMENT GUIDELINES

Cabinet members or Lions who are part of the agenda are not allowed to partake in the 'borrowing'. Special occasions, such as zone or chairperson meetings, charter nights, or any public meetings are also off-limits. Being a good host to hundreds of people is tough enough without having to worry about the club equipment. Be creative, enjoy the host's discomfort, but above all, act in good taste. The purposes of 'finding' another club's equipment is to foster goodwill and promote friendship. When the items are taken, you must notify the visited club within forty-eight (48) hours as to what item was taken and when the club meets again so they may retrieve the item for a small donation to a favorite Lion's charity.

IRS REPORTING REQUIREMENTS

Numerous Lions Clubs file an annual form 990 or 990-EZ with the IRS because of their tax-exempt status and size. Other clubs should understand that small tax-exempt organizations whose gross receipts are normally \$50,000 or less are not required to file Form 990 or Form 990-EZ, Return of Organization Exempt from Income Tax. However, with the enactment of the Pension Protection Act of 2006, these small tax-exempt organizations are required to file an electronic Form 990-N with the IRS annually.

Form 990-N, also known as the e-Postcard, must be filed electronically. There is no paper form. The e-Postcard is due every year by the 15th day of the fifth month after the close of the tax period. For Lions clubs, this deadline is November 15.

33K EYEMOBILE HISTORY

There have been several vehicles and trailers named the Eyemobile, all with the purpose of providing free neighborhood health screenings emphasizing vision care and the preservation of eyesight. The first until was a dream of sitting DG Arthur Metzger in 1970. It was a used furniture van donated by Lion Ed Lynch of the Somerville Lions Club.

This van was replaced in 1972 by a movable trailer. The Somerville and Waltham Lions Clubs raised money to acquire the new unit, while several Clubs donated funds to purchase the necessary medical equipment. 60 feet long and 10 feet wide, it was furnished with a bathroom and was painted by members of the Malden Lions Club. The first user of the new trailer was the Brighton Lions Club.

In 1972, the Lions of District 33K elected to accept the Eyemobile and its mission of providing free health screenings as a district project and expanded its area of coverage to include 58 communities, in and around the greater Boston area. The Eyemobile also became a non-profit corporation, a wholly owned entity of the Lions Clubs of District 33K. PDG Arthur Metzger was elected its first president, serving until 1988.

The Eyemobile trailer was used until 1988 when another movable trailer with new medical equipment replaced it. After screening

thousands of clients, the second movable trailer was retired in 1988.

In the spring of 1998 a modern self-powered Winnebago vehicle with then state-of-the-art medical equipment was inaugurated. This was the result of a two-year fundraising effort – \$180,000 raised through the generosity of the Lions Clubs of District 33K, plus several grants including from LCIF.

We purchased our current vehicle, a new Winnebago with new equipment, placing it into service spring of 2018, again through the generosity of the Lions Clubs of District 33K and a matching grant from LCIF.

The Eyemobile has provided a variety of health screenings to over 25,000 children and adults. These include vision, glaucoma, diabetic retinopathy, macular degeneration, hearing and blood pressure screenings on a gratis basis.

The Eyemobile is used at local health fairs (senior citizens), community functions, school functions, fairs and parades, and other Lions sponsored activities.

In the summer of 1950 E. Daniel Johnson, District Governor 33N, had a visit from a friend on his farm in Lyndeboro, New Hampshire. This friend brought his four-year-old blind son, a so-called 'blind baby' or 'retrolental fibroplastic' baby, with him. The cause was unknown; the child was apparently blind at birth. In talking of this with Harry Hartford, then District Governor of District 33K, Lion Johnson found that Harry had a friend, Al Hirshberg, who had a blind baby that was born on the day that Al landed in France, D-Day 1944.

In October of 1950, they and a small group of Lions had lunch with Al Hirshberg (Sportswriter for the Boston Post and Chairman of the Foundation for Eye Research) and Dr. Edwin B. Dunphy (Professor, Harvard Medical School and Chief of Staff, Massachusetts Eye and Ear Infirmary). This small assembly of Lions was told of the existence of a new disease, first discovered in Massachusetts in 1941 by a Dr.

Terry. Physicians knew this disease as “Retrolental Fibroplasia”.

This disease was not only baffling but also discouraging because no funds were available to attempt to discover its cause. The Lions of Massachusetts were asked to try to do something to help the medical profession in raising funds to combat this terrible disease which was afflicting four out of five premature babies weighing four pounds or less.

This story was so amazing that the Lions asked Al to write a pamphlet, telling this story that they could carry to the Lions Clubs throughout Massachusetts. Dr. Dunphy edited this pamphlet and Lion Johnson had several thousand copies printed and mailed to all Lions in Massachusetts and to all District Governors in the United States and Canada at his own expense. In 1952 Eye Research was voted to be the official project of the Massachusetts Multiple District 33 Lions.

DISTRICT GOVERNOR'S EMERGENCY FUND HISTORY

The District Governor's Emergency Fund was established by District Governor George Nielson in 1982. The Fund was originally funded by a donation from District 33A in the aftermath of the "Blizzard of 1978". Since that time, every District Governor of 33K has supported the fund.

The District Governor's Emergency Fund depends upon the generosity of the clubs in 33K. The fund is used to meet requests for financial assistance when an individual club cannot assist a worthy recipient. When possible, the fund provides assistance when they meet the humanitarian goals of the district and association.

WHITE CANE IN AMERICA



In the United States, the introduction of the white cane is attributed to George A. Bonham, president of the Peoria Lions Club. In 1930, a Lions Club member watched as a man who was blind attempted to cross the street with a black cane that was barely visible to motorists against the dark pavement. The Lions decided to paint the cane white to make it more visible. In 1931, Lions Clubs International began a program promoting the use of white canes for people who are blind.

The first special White Cane Ordinance was passed in December 1930 in Peoria, Illinois granting blind pedestrians protections and the right-of-way while carrying a white cane.

On October 6, 1964, a joint resolution of the Congress, HR 753, was signed into law authorizing the President of the United States to proclaim

October 15 of each year as “White Cane Safety Day”. President Lyndon Johnson was the first to make this proclamation.

White Cane Safety Day is observed at The State House annually in October. Lions are encouraged to attend to mark the progress that sight-impaired citizens have made.

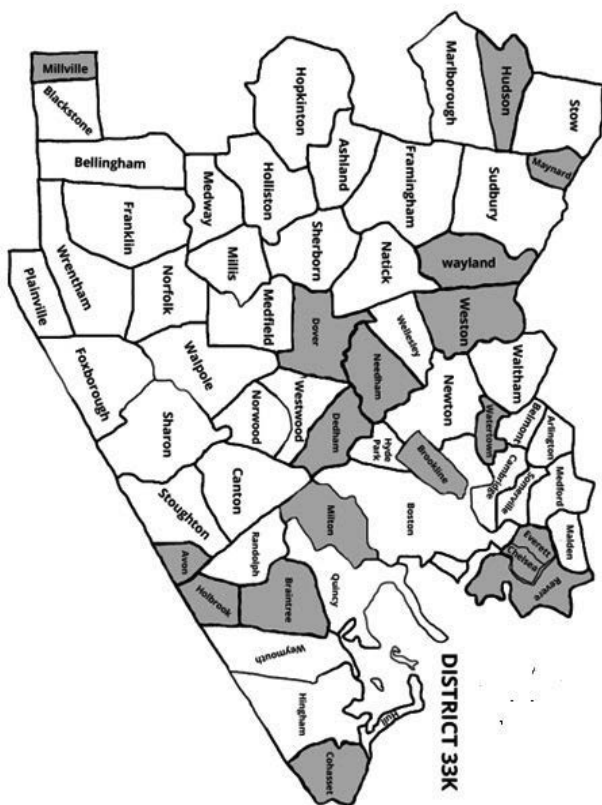

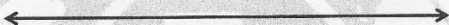
